Guardianships in Colorado

We here at PASCO understand the importance of valuable information that can assist our community in navigating the complex situations that arise as our loved ones get older. That's why PASCO arranged to have Chris Brock, Managing Attorney of CCDC Probate Program, give an informal talk about Guardianships in the state of Colorado.

Guardianship Frequently Asked Questions

When is a Guardianship Necessary?

At age 18, an individual is considered an adult and presumed to have legal capacity.

If an adult is "unable to effectively receive or evaluate information, or make or communicate decisions to such an extent that the individual lacks the ability to satisfy essential requirements for physical health, safety, or self-care, even with appropriate and reasonably available technological assistance," then Colorado Probate Code states they are considered an "Incapacitated Adult."

When to file for Guardianship?

If Guardianship is the correct path for your child with special needs, contact an attorney or start the process online before at least one month before their 18th birthday.
